# MVCCA: Update on sanitary sewer line replacement

The county is replacing a sewer line that runs under the streambed of Little Hunting Creek. In May, soil borings in the creek and the eastern and western shorelines were taken using truck-and barge-mounted rigs. The borings confirmed that more structure (pilings) will be needed to support the new sewer line; gravel bedding will not be enough.

The county is about 35% through the design stage now. They have a preliminary alignment that's a little south and parallel to the current alignment.

The county is also working on permitting requirements and looking at the staging of the construction work. No certain word yet on when that will be.

# MVCCA: Renovation & expansion of the Mount Vernon RECenter

Construction on the first phase will start in February 2020, with an estimated completion date of July 2022.

The first phase of the renovation and expansion will include a complete overhaul of the center's existing pool, an expanded two-floor fitness center, fixes to the ice rink and a completely reworked entrance area.

Phase 1 is the only phase fully funded at this point, and also includes funding for the design of a new ice rink, which is planned for Phase II.

Phase III includes plans for the addition of a leisure pool.

### SLCA RESOLUTION (as amended by the SLCA Executive Committee 7/10/18)

1. WHEREAS, the Mount Vernon Council of Citizens Associations, representing the citizens' associations of the Mount Vernon magisterial district, takes positions on issues of concern to its members and the Mount Vernon community, and presents them to Mount Vernon's elected representatives and other government entities;

2. WHEREAS, the credibility of the MVCCA is harmed by financial conflicts of interest on the part of its officers and committee members which appear to influence the positions taken by the MVCCA;

3. WHEREAS, MVCCA by-laws (Article VI, Section 5) state that, "In order to maintain the nonpartisan status and reputation of the Mount Vernon Council, no person who is a candidate for, or holds, an elective position with Fairfax County, who is an officer of a political party, or otherwise has a conflict of interest, may serve as an Officer or a member of the Board of Directors. A removal under this section shall be considered a removal for cause."

4. WHEREAS Roberts' Rules (section 45, p. 405, 11 th edition) states that, "No member should vote on a question in which he has a direct personal or pecuniary interest not common to other members of the organization";

5. WHEREAS, current MVCCA Board policy is for officers and members with financial conflicts of interest to disclose the conflict, but does not mandate their recusal from debate, voting or other participation, and, contrary to Roberts' Rules, allows them to vote, and fails to limit their using the MVCCA to advance their own financial interests;

6. WHEREAS, disclosure alone provides some transparency, but provides weak or no protection from the reputational damage and corruption of its mission that MVCCA can suffer from financial conflicts of interest;

7. WHEREAS, merely disclosing conflicts of interest will further discredit the MVCCA when the conflicts are widely publicized;

8. WHEREAS, MVCCA does not have an effective procedure for notifying member associations and their representatives in a timely way that their dues are overdue and therefore their representatives have lost voting rights;

9. WHEREAS, nonpayment of dues has been enforced selectively and without notice to committee members and this selective enforcement has prevented some committee members from voting or speaking in committee meetings;

Therefore be it resolved, the Stratford Landing Citizens Association requests the MVCCA to revise its bylaws and policies to ensure stronger provisions, including recusal, to prevent financial conflicts of interest.

Be it further resolved, the SLCA asks that MVCCA develop better procedures for timely notice to members of dues nonpayment that are more respectful of member associations and their representatives.

Mount Vernon Council of Citizens' Association Environment and Recreation Report

#### Proposed development on Dogue Creek

The committee's recent meetings have been dominated by discussion of a proposed amendment to Fairfax County's Comprehensive Plan to allow 43 townhomes to be built at 8800 Richmond Highway. This 8-acre property, a former junkyard, has long been an eyesore and detriment to the community. The parcel along the highway is zoned "commercial", and to its north lie two parcels zoned "residential, 2 dwelling units per acre". All three parcels are almost entirely in the Chesapeake Bay Resource Protection Area and the 100-year floodplain. They are recognized as part of the Dogue Creek Environmental Quality Corridor and protected by Fairfax County's Comprehensive Plan and several ordinances. They are currently planned for open space.

The E&R Committee debated and passed a resolution supporting (with conditions) a plan amendment to allow development, which was then amended and passed by the MVCCA General Council. The county staff report, issued after the MVCCA vote, strongly recommends against the amendment. At a July 19th public hearing of the Planning Commission, proponents (including the property owner and agent for the developer, MVCCA, the Sacramento shopping center owner, and local neighborhoods) testified that the plan amendment would help revitalize the Route 1 Corridor, and clean up a property that has long been a drag on the immediate neighborhood. Opponents (including Friends of Little Hunting Creek) testified that the

standards set by county and policy that such encroachments should only be allowed in "extraordinary" circumstances, and only where environmental benefits clearly outweigh harms. They said that approving the amendment would open the door to development in currently protected riparian areas and floodplains, and a better use of the land would be to provide public access for kayaking, canoeing, fishing, and birding in Pole Road Park and Dogue Creek.

The Commission postponed a decision until September 13th, and comments are being accepted until then. Send your comments on Plan Amendment 2018-IV-MV2 to <u>plancom@fairfaxcounty.gov</u> and <u>dan.storck@fairfaxcounty.gov</u>.

In the course of debate over this property, several E&R members strenuously objected to the fact that MVCCA Board members had conflicts of interest because they are an owner of the property, real estate agent for the property, or agent for the developer. Although they disclosed their conflicts of interest, the Board members did not recuse themselves, and actively participated, arguing for passage of a resolution in favor of the development in which they have a financial interest. SLCA passed a resolution (Page 5) objecting and asking MVCCA to revise its bylaws to better address conflicts of interest, and plans to meet with the new co-chairs to discuss.
