

BASKETBALL HOOPS

In communities across the country, residents are sometimes conflicted over residential "street play." Many parents who themselves grew up playing sports in their own neighborhood streets find their children are actually prohibited by law from doing the same.

In Fairfax County, for example, code regulations require basketball hoops to have a 15-foot setback from the roadway. This applies to our neighborhood. Kids playing basketball in the street are actually not allowed to do so, and basketball hoops in particular, by law, should be well into a home's driveway.

LITTLE HUNTING CREEK CLEANUP

Thanks to Stratford Landing residents Celia Boertlein, who led the removal of English ivy and other invasive vines at the Northern Virginia Conservation Trust site, and Paul

Siegel, who led the Stratford Armada in canoes and kayaks to clean up trash in the creek, as well as the neighbors who turned up to help.

Friends of Little Hunting Creek also cleaned up sites in First River Farms, Gum Springs,

Riverside Estates, Colonel John Byers Park, and White Oak Park. So far, 83 volunteers have picked up 123 bags of trash and recyclables, 3 tires, one shopping cart, and 334 pounds of bulk trash.

WHERE (AND WHERE NOT) TO WALK ALONG LITTLE HUNTING CREEK ...

Many people enjoy walking their dogs and strolling along Stockton Parkway to catch the views of Little Hunting Creek. While they may freely enjoy the views offered by the creek side lots on Stockton Parkway, they should clean up after their pets, be respectful of other's property, and not enter unless they have the specific permission of the owner (or unless sign indicates a access allowed). The lots are private property. Be aware of "no trespassing" signs. An alternate route is the little trail through the wetland area at the site owned and preserved by the Northern Virginia Conservation (https://www.nvct.org/) at the end of Stockton Parkway adjacent to the pump station.

MVCCA P&Z Committee April 1, 2019

A resolution to support granting of special exception to allow gas pumps to be put at the 7-Eleven on Lukens (across from Engleside Plaza) was passed by the committee. Also in the resolution was the suggestion of present or future charging stations and possible future solar panels.

The committee passed a resolution to support a zoning ordinance amendment to allow gardening in front yards on properties with less than 36,000 square feet (100 square feet in size and 15' from the front property line.) The resolution to support included the provision that the amendment not supercede Home Owner Association and Condo Association bylaws.
