News from the MVCCA

Transportation Committee

The committee is working with the Board of Supervisors on airplane noise; coordinating with Lee District on North Kings Hwy asking for more sidewalks and narrower lanes; reviewing FCDOT and VDOT to adopt Complete Street Policy, which would measure not just how long a car waits at a stop light, but also how long pedestrians and bikes wait, whether it is safe, etc.; the National Park Service will brief the committee on its plan for safety measures for the GW Parkway; and seeking accurate numbers for undergrounding of utilities along Route 1.

Public Safety

The Committee is developing a work plan with the following topics: speeding in neighborhoods, police staffing and reform and pedestrian safety.

General Council Meeting, Dec. 16 - Resolutions Passed

At the General Council meeting on Dec. 16th, the members passed 4 Resolutions. The 2 Education Resolutions urged that the Board of Supervisors (BOS) and Fairfax County Public Schools (FCPS) include substantial additional investment in FCPS in on-going budget development for the 2022 school year and that the MVCCA supports teacher priority in COVID-19 vaccine distribution. The Planning and Zoning resolution opposes additional special exemptions for multi-pump stations/convenience stores along Route 1 and the Joint Transportation, Planning and Zoning and Public Safety resolution with Lee District supports improving the current and planned design of the North Kings Hwy. road and sidewalks between School St and the Huntington Metro.
